


VISITOR PRE-SCREENING FOR COVID-19 AND TOUCHLESS VISITOR CHECK-IN ON ARRIVAL

Businesses need to proactively pre-screen and log the potential COVID-19 exposure of visitors & contractors before their arrival on your premises, and also need to provide a seamless and touchless check-in process for visitors on arrival. The WizzPass Visitor System provides both.



Pre-screening of visitors:

Pre-book visitors and contractors through WizzPass and your visitors and contractors will automatically get a pre-arrival email and/or SMS with a link to pre-register and complete the pre-registration and COVID-19 pre-screening procedures:

✓ Visitors complete a COVID-19 guestionnaire before arrival

If an undesired answer is captured, visitors will be informed they will not be allowed to check-in at the premises and their host, the on-site clinic, building security and/or the risk department will be notified. For example, if they are suffering from any flu-like symptoms, they will not be allowed to pass the health assessment and will not be allowed to visit your building.

✓ Visitors sign a COVID-19 Health & Safety agreement before arrival

Visitors will acknowledge, accept and digitally sign your company's COVID-19 screening agreement before their arrival, verifying that they have completed the COVID-19 questionnaire truthfully and honestly. Your company will have access to all signed agreements on record on the WizzPass dashboard. This agreement will also be automatically emailed to the visitor for their records.

*Alternatively, if the visitor was not pre-booked, then the visitor will need to complete the screening assessment and signing of the Health & Safety agreement on their arrival.

On arrival screening and touchless logging of visitors Depending on your preference, you can choose which

touchless visitor logging process suits each of your visitor access-points the best: ✓ WizzPass web-dashboard used by receptionist

Reception/security staff can use their WizzPass Receptionist Dashboard at the reception desk (on their PC or laptop), to capture the visitor's details upon arrival, including their health assessment questions and their temperature reading.

The WizzPass web-dashboard can be used at security desks or reception desks.

✓ Handheld scanner used by security officer Security/reception staff can make use of the WizzPass

handheld scanner to scan the visitors driver's license, South African ID card, ID book or capture their details manually, take a photo of the person and select the host (and host will automatically be notified of visitor's arrival). Other fields can also be enabled such as company name, visitors' mobile number, and the temperature reading that was captured. The handheld scanner can be used at access-points

such as parking gates, or door-entrances.

QR code scanning on WizzPass check-in kiosk In the pre-arrival email (or the company's white-labelled

visitor smartphone app) visitors can make use of their

booking QR code to scan themselves in on the check-in tablet at the reception area. The visitor just holds up their QR code (on their phone) to the camera of the tablet. The system then instructs the visitor to complete the COVID-19 screening assessment, and once completed will automatically notify the host of their visitor's arrival. The visitor's check-in timestamp will then show on the WizzPass dashboard and the receptionist/security officer can then just input the visitor's temperature onto the dashboard. The WizzPass check-in kiosk is a tablet device mounted on a secure stand, so it can be used on any security desks

or reception desks, or can also be wall-mounted. ✓ Facial recognition on WizzPass

Similar to the QR-code option above, using the latest facial recognition technology on the WizzPass check-in kiosk, WizzPass is able to allow a touchless visitor

the check-in kiosk and show their face to the screen. Advanced facial-security checks are also enabled such as distance required from camera and angle of face. The system then instructs the visitor to complete the COVID-19 screening assessment (if not complete already), and will then automatically notify the host of their visitor's arrival. The visitor's check-in timestamp will show on the WizzPass dashboard and the receptionist/security officer can then just input the visitor's temperature onto the dashboard. The WizzPass check-in kiosk is a tablet device mounted on a secure stand, so it can be used on any

View all health assessments and signed health agreements directly on the WizzPass dashboard and take the necessary action or precautions if there are any flagged results.

Notifications are also automatically sent to security and/or health officers should any visitor have any undesired COVID-19 declarations or testing results. All reports are also exportable to CSV or PDF and searchable using multiple filter options for health auditing and compliance purposes.
